## **Poultry Council: 1 October**

The following key matters discussed were:

- Preliminary repayment arrangements for H7N6 Otago
- Project options for the first annual Work Programme Options
- In-kind contributions versus minimum commitments
- Identification of next steps for each project, including scoping, further investigation, or holding over pending other work.
- Scheduling of next meetings.

# Foot and Mouth Disease Council (FMDC): 10 October

The following key matters discussed were:

- Council's reporting requirements
- The appointment of an external provider to provide project lead services for work on Operational Plans and Workforce Planning
- The newly established first annual readiness work programme with projects as follows:
  - Updating Operational Plans
  - Workforce Planning in an FMD Response
  - Response Governance Exercise
  - Compensation Review
  - FMD Equipment and Stores
  - Vaccination Antigen Bank
  - FMD Response Industry Communications
  - Updated budget, including the treatment of in-kind hours
- FMDC Meets again on 9 December 2025.

### GIA Operations Limited (GOL) Board Planning Session: 21 October

The following key matters discussed were:

- Signing off the 24/25 accounts, including the Overhead readjustment and surplus to be refunded to partners
- Variation to the Service Level Agreement between GOL and MPI to accommodate increases in readiness expenditure through the FMD and Poultry OAs
- Agreement to enter a contract for services on behalf of the FMD Council
- Year-to-date financials (July–September financial performance report)
- Biosecurity Legislation review
- Livestock and Plant Sector progress in GIA
- Sector-specific readiness activities
- Possible review of the GIA Strategic Framework
- Options for the next review of the GIA Deed.

### **Plant Pass Biosecurity Scheme**

- Plant Pass Version 2.0 consultation is underway with feedback being analysed from producers, auditors, and partners to refine the Checklist while maintaining high biosecurity standards.
- Sector Audit Model is progressing, combining central coordination with independent delivery to improve audit consistency and regional coverage.
- Producer participation: 100 total (85 active); 28 certified. Celebrating all NZ Winegrowers nurseries who are now fully certified.
- The first Regional & Unitary Council Forum was held with strong attendance and a focus on alignment between biosecurity and procurement.
- Plant Pass welcomed *Better Biosecurity Solutions Ltd* as a new Partner, bringing additional technical and field-based biosecurity expertise into the network.
